CHIEFS REPORT

Chief Dorothy reviewed the Chiefs Report sent out prior to the meeting. Chief Dorothy informed the Board of the following:

- Presented Junior Firefighter Hunter Feighenbaum application to the Board. Commissioner Spahr made a motion to accept Junior Firefighter Hunter Feighenbaum effective April 14, 2022, with the customary 6-month probationary period. Commissioner Borte seconded the motion. Motion carried.
- 2. Matt & Angie Bartholomew submitted applications and are now going through the application process.
- 3. Kevin Weeks has been cleared to return to full duty effective April 4, 2022.
- 4. Seattle to Portland Bike Ride. The Association is on the list of overnight accommodations.
- Chief Dorothy stated he found the cost for used Conex Box to be approximately \$4000.00.
 Chief will continue to look for used boxes for trainings. Commissioner Borte suggested to

- look around in the community and see if we someone is interested in donating Conex boxes. Possibly advertise on our department website and Facebook pages.
- 6. Chief Dorothy stated the Durango has a water leak in windshield. Currently scheduled for repair at the dealership.
- Volunteer Kyler Reed will be graduating from the Academy on April 21, 2022. Chief Dorothy will be attending his graduation.

UNFINISHED BUISNESS

- Advisory Position: Chairman Moore advised the Board that Advisor, Diane Wallace accepted the Board's offer to extend past the original agreement end date of April 30, 2022. Diane will remain the District Advisor until further notice.
- 2. Agreement for Provided EMS Services-
 - Adventure Medic: The Board agreed to table this item at this time.
 - Life Flight: It was the decision of the Board to bill Life Flight for future service without a contractual agreement.
- 3. Employee Handbook Draft Revision: Chairman Moore suggested we have a special meeting on just this subject. Chairman Moore set a date of April 27, 2022, at 5:00p.m.
- 4. DNR Grants (3):
 - Phase 2 Radio Grant: Chief Dorothy reported the department was awarded ten radios.
 The radios have been ordered.
 - Infrastructure Grant: Application has been submitted.
 - PPE Grant: Application has been submitted.
- 5. Lewis County Investment Pool Agreement: Chairman Moore read the Lewis County Investment Pool Agreement to the board. Commissioner Spahr made a motion to sign the agreement. Commissioner Borte seconded the motion. Motion carried. Chairman Moore signed the agreement.

NEW BUSINESS

- Lewis County Medic One- March Meeting: Chairman Moore gave an update on the March meeting.
- 2. WSFFA Fire School Training- Wenatchee May 19-22, 2022: Chief Dorothy asked the Board to send Chris Davidson to the training. All classes Chris attends he will incorporate into future trainings for the department. Commissioner Borte made a motion to pay class registration fee, hotel for a 3-night stay, food, provide a department vehicle and fuel per department policy. Commissioner Spahr seconded the motion. Motion carried.
- 3. Fire Department Website: Chairman Moore discussed the current condition of the website. Discussion followed. It was agreed the website needed to be overhauled. The District Secretary will review and update.
- 4. 2020-2030 Comprehensive Plan: Chairman Moore discussed the need to update the plan on a yearly basis in December. Time period should always be a rolling 10 years.
- First Quarter-Budget Review: Due to calculation errors the Board requested that it be corrected and brought back to the May meeting.
- 6. District 15 Commissioners: Chairman Moore expressed the need for the Board to talk with neighboring Fire Districts concerning current and future EMS and Fire protection

services, planning for Industrial, business, and residential growth. Commissioner Spahr asked Chairman Moore to contact District 15-Winlock to scheduling a meeting with District 15 Commissioner's Board at one of their meetings.
